Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Others - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Six is a firm specialized in offering brand & communication, culture & change, digital experience and sustainability consultancy solutions. The company has had clients from controversial industries such as the fossil-fuel (non coal/oil sand) industry. The nature of the company's services provided to the clients in the fossil-fuel industry was limited to digital infrastructure related to carbon management products and supporting culture change programmes. All of the company's services can be sold to both controversial as well as non-controversial industries, though the company's services are tailored to specific client needs.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2023, an estimated total of 24% of revenue was generated through clients in the controversial industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Six currently does not have a formal position on working with sensitive industries or a policy to move away from them. When choosing to work with high emitting industries, the company follows a considered approach based on two key principles: • Thorough Due Diligence: The company reviews potential clients and only works with those that have a genuine

	commitment to sustainable development. • Meaningful Impact: The company only partners with companies when it believes that its involvement will make a significant, positive difference in the clients' sustainability efforts.
Management Comments	"We understand and respect the reasons why people turn away from high-emitting industries, and we completely recognise the importance of accountability and compensation. However, we believe supporting these industries to decarbonise is an essential part of the puzzle required to drive the large-scale sustainable development the world needs. Instead of excluding industries and businesses out of hand, we are happy to combine our expertise with their experience and infrastructure to help us all transition away from fossil fuels."
