Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Animal Products and Services

Topic	Company is a distributor and sources >50% of their raw material expenses from animal products, specifically fish.
Summary of Issue	Ocean Brands sources from multiple types of fishing systems, including large fishers and small scale, the majority are large fisheries in terms of cost. Ocean Brands sources approximately 35% of fish from Thailand, which is known for human rights violations for the fishing industry .
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	90% of the company's revenue comes from fish related products. Most product is wild-caught from fisheries around the world, maintenance of sustainable fish stocks is a critical pillar of sustainable sourcing.
Impact on Stakeholders	Ocean Brands has a commitment to Marine Stewardship Council (MSC) certified fish where possible, and when this option is not viable, it also prioritizes other sustainable fishing methods including pole & line fishing, fisheries in Fishery Improvement Projects, FAD-Free methods, and Circle Hook catch. Implemented Management Practices	Ocean Brands has set targets and reports on progress. This is reported publicly on the Ocean Brands website, here: https://oceanbrands.com/sustainable-fishing/ . Attention to section "Sourcing Goals and Tracking". The goals are specific to each type of fish, including MSC certification, Ocean Wise recommendation, Pole & Line catch, and sourcing through FIPs (Fishery Improvement Projects), which are multi-stakeholder initiatives aimed to improve the health of fisheries. In relation to the potential human rights violations in Thailand, the company requires suppliers to uphold Code of Conduct which aligns with the United Nations Guiding Principles on Business and Human Rights and the International Labor Organization C188 Work in Fishing Convention. In addition, the company verifies the social performance of suppliers through independent third-party



	assessments such as BSCI, SMETA, or SA8000 ethical audit standards. The company also actively engages in industry association that focuses on developing collective solutions to the problem of forced labor in the industry.
