- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process

Disclosure Questionnaire Category: Other - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Avancargo is an On Demand and SaaS company that has clients in the Mining and Fossil Fuel (excluding coal, oil sands) industries. The nature of the company's services with clients in these industries has been related to both trucking and software for freight forwarders, logistics operators and carriers, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the Mining industry represented 4% in FY21-22. The revenue from clients the Fossil Fuel - Other industry represented 28% in FY21-22.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Avancargo has no position on working with clients in sensitive industries. However, before committing to any client or project related to controversial industries, the company will conduct a comprehensive evaluation of the associated ethical, legal and reputational risks.

Disclosure Questionnaire Category: Tax Reduction Through Corporate Structure

Topic	Corporate Structures in Tax Havens
Summary of Issue	Avancargo is a logistics company with a parent company based in the British Virgin Islands, which has a score of 100 on the Corporate Tax Haven Index. The company has operations and corporate structures in Argentina, Uruguay and Chile.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the FY2023, the overall effective tax rate for the company was 0% as the group is loss making with no accessible profit. The company expects to pay taxes at the operational level once they reach the breaking point.
Impact on Stakeholders	In addition to the many different aspects of value that business provides society, business has an obligation to contribute its share of taxes. This is because business exists within the context of society; its proper role is to serve society, not the other way around. Moreover, healthy businesses can only exist over the long term in a healthy society. A healthy society depends upon public expenditures made possible by taxes.
Implemented Management Practices	Avancargo's corporate structure and tax compliance ensures that taxes are paid at subsidiary level in the territories where it operates and employs individuals. Most employees and operations are based in Argentina. When these companies return to a taxable profit position, they will pay corporation tax in Argentina on their profits at 25%. Similarly, employees and operations of the subsidiaries in Uruguay and Chile are required to report to local tax authorities. If these subsidiaries become profitable, they will pay corporation tax locally at the relevant rate.
