Topic	Clients in Controversial Industries
Summary of Issue	Good Rebels provides marketing services and has had clients operating in the Alcohol, Fossil Fuel (coal, oil sands), Pharmaceutical, Marketing of Breastmilk Substitutes, For-Profit Higher Education and Tobacco industries over the last 5 years. Services to these clients included projects aimed at improving employee advocacy of the brand to attract talent, brand related projects as well as website redesign execution of digital marketing strategies. Services provided by Good Rebels can be sold to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>Clients in the Alcohol industry are on-going and represented a total of 3.38% of the company's revenue in FY2022.</p> <p>Clients involved in the Fossil Fuel (coal, oil sands) industry are ongoing and represented a total of 4.52% of the company's revenue in FY2022.</p> <p>Clients in the Marketing of Breastmilk substitutes were a one-off engagement in 2021 and represented 0.70% of the company's revenue at the time.</p> <p>Clients operating in the Tobacco industry represented 0.61% of the company's revenue in FY2022 and represented on average 0.68% of the company's revenue over the last 5 years. The company no longer works with this client.</p> <p>Clients in the For-profit higher education industry was a one-off engagement in FY2020, representing 0.83% of the company's revenue at the time.</p> <p>Clients in the Pharmaceutical industry are on-going clients and represented 1.42% of revenue in FY2022. Over the last 5 years, clients in this industry represented on average 3.5% of the company's revenue.</p>
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.

	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	<p>The company is committed to no longer work with clients in the Tobacco industry. Company's projects involved in both the alcohol and fossil fuels industries are based on improving the training and employer branding of the company. They are advocacy projects that work to improve awareness surrounding sustainable practices and ethics.</p> <p>Company has been working with Repsol to execute their 2050 strategy, to bring awareness to the initiative whilst also defining the rollout.</p> <p>Company now only works with 1 alcohol company which represents 0.3% of its total 2023 revenue. However, the company has been defining and creating campaigns/initiatives with the company to improve their commitment to, and encourage their consumers, to adopt sustainable practices.</p> <p>Company is not involved in the production of its clients.</p>
