Disclosure Questionnaire Category: Praxis Consulting Group

Topic	Clients in Controversial Industries
Summary of Issue	Praxis Consulting Group is an organizational development and management consulting company that has offered its services to clients in the Gambling and Animal Products and Services Industry on an occasional basis over the last 5 years. The company's service for clients in the gambling industry involved helping the client communicate the termination of their Employee Stock Ownership Program and the service offered to Animal Products and Services clients has involved assisting in communication, culture building, and leadership development. The service offered by Praxis Consulting Group can be sold to companies in both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Praxis has had 1 client operating in the Gambling industry over the last 5 years, representing less than 1% of the company's total revenue between 2018 and 2019. The company no longer works with clients operating in the gambling industry. The client in the Animal products and Services industry represented 0.66% of revenue in total in FY2022.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not currently have a position in working for companies in sensitive industries. However, Praxis has decided to stop working with companies operating in the Gambling industry since 2018 and the company has turned down working with clients when they believe the primary focus of their products or services causes direct harm to people. In addition, historically the company has turned down work or has not



	actively pursued companies that directly manufacture military weapons or military security services.
