

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to coronavirus pandemic
SUMMARY OF ISSUE	Due to coronavirus pandemic Meu Copo Eco had to layoff some of its workforce. Its former employees were fired in one round, which lasted from April until July 2020.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	37 employees were laid off, representing 55,22% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	- All former employees received unemployment insurance in three to five installments, which vary according to the period worked, - The company paid the following severance pay: • Salary balance, • Early warning, • Expired vacations, • Proportional vacations, • Addition of 1/3 of vacation, • Proportional salary, • Indemnification of 40% of FGTS deposits. - For those dismissed employees that could not relocate themselves professionally had the option of accessing emergency aid provided by the Brazilian government, - The company gave all the necessary administrative and accounting support, - Meu Copo Eco gave, for those that wanted to, a basic-needs grocery package to support the laidoff employees.
