Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Services to these clients have been related to: Inclusive leadership development, diversity, equity and inclusion strategy and developing the tools to support and help their clients create a more inclusive and psychologically safe workplace for their employees. All services can be offered to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>From the company's FY2023 revenue, clients operating in controversial industries represented:</p> <ul style="list-style-type: none">• 1% of revenue from clients in the Alcohol industry and has had revenue from clients operating in this industry on an ongoing basis over the last 5 years, representing an average of 2.4% of total revenue.• 0% of revenue from clients in the Defense, Offensive Firearms, and Weapons industry. The company had a one-off engagement with a client in this industry in 2018 representing 0.02% of their revenue. This is not a current client.• 0% of revenue from clients in the Fossil Fuel (Coal, oil sands) industry. Revenue from clients in this industry represented less than 1% of revenue on average over the last 5 years. The company does not currently have clients operating in this industry.• 0% of revenue from clients in the Gambling industry. Revenue from clients in this industry represented less than 1% of revenue on average over the last 5 years. The company does not currently have clients in this industry.• 0% of revenue from clients in the Pharmaceutical industry. The company had a one-off engagement with a client in this industry in 2018 representing 0.5% of revenue. This is not a current client.

Implemented Management Practices	<p>Charlotte Sweeney Associates has a position on working with controversial industries and will not work with any company related to the sex industry.</p> <p>With regards to other sectors, the company has a due diligence process in place for evaluating potential new clients. The company's entire management team explores how the company is either supportive or against ethical, environmental and social values and commitments they have. This process involves reviewing the company's work on ESG, their current and longer-term commitments, how they are going to drive ESG change in their business and how their senior leadership talk or act on the subject.</p> <p>Charlotte Sweeney Associates continually monitors what their clients are doing to evaluate whether there is something that conflicts with their position or values and whether to work with them in the future.</p>
