Tom's of Maine is involved in the Palm Oil Industry. This industry is reliant upon materials at high risk of human rights infringements, meaning that the company is responsible for ensuring they have enough practices and policies in place to prevent and mitigate negative impacts in their operations and value chain. Based on the size of the company, these impacts may be limited. Certified B Corps are required to make transparent their involvement in such industries.

Topic	Litigation, Arbitration, and Penalties related to consumer protection and labor
Summary of Issue	<p>In the past five years Tom's of Maine reported twenty one (21) consumer protection lawsuits and one labor-related lawsuit. Consumer cases include allegations related to misleading advertising, such as the use of the term "natural" (n=4), general misleading advertising claims (n=4), toothpaste tube recyclability claims (n=1), potential contamination involving PFAS/heavy metals (n=3), litigation related to an FDA Warning Letter (n=6), and claims about children's fluoride oral care products (n=3).</p> <p>The cases related to the term "natural" and misleading advertising were settled (n=6) and dismissed (n=2). The cases related to the toothpaste tube recyclability claims (n=1) are pending. The cases related to potential contamination of PFAs/heavy metals were settled (n=1), pending (n=1) and dismissed (n=1). The cases related to the FDA Warning letter (n=6) are in the phase of approval of class action settlement. The cases related to claims about children's fluoride oral care products are pending (n=1) and dismissed (n=2).</p> <p>Additionally, the company has one (n=1) settled labor litigation.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>The lawsuits that were settled were settled with financial impacts representing less than 1% of the company's annual revenue.</p> <p>The proposed class settlement of the cases related to the FDA warning letter would create a settlement fund of USD 2.9 million, covering all claims, attorneys' fees and costs, and settlement administration costs. The settlement remains subject to final court approval.</p>
Impact on Stakeholder(s)	The purported impacted stakeholders are consumers and one employee.
Resolution	Some of the lawsuits resulted in judgments in favor of the Company, some were settled, and some remain pending. In all



	cases, Tom's maintains the appropriateness of the claims at issue and its conduct, and any settlements in no way constitute admissions of liability or wrongdoing.
Implemented Management Practices	Tom's ensures its products are advertised accurately and in compliance with applicable laws and regulations. Tom's has also implemented corrective actions to address issues identified in the FDA warning letter. Tom's maintains policies prohibiting discrimination, harassment, and retaliation, supported by its Code of Conduct, EEO and Anti-Harassment policies, and employee training programs.
