Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Located in Argentina, the company offers communication consulting services focused on improving the well-being of its clients' employees, and internal advertising strategies. The services are diagnosis, planning and management of communication with its internal staff (employees). The company has confirmed that they don't provide services for external facing marketing relating to the branding/marketing strategy. Abcom has clients in the following controversial Industries: - Gambling - Fossil Fuels (including one company from mining) - Genetically Modified Organisms
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	"During the last FY perod (2020-2021), revenue from fossil fuels, gambling and genetically modified organism clients represented 5% of total revenues.
IMPACT ON STAKEHOLDERS	The services provided in employee communication tend to improve the work environment, collaboration and teamwork, the motivation of employees in achieving objectives or adaptation to changes in the organization.
IMPLEMENTED MGT PRACTICES	Abcom only works with companies that comply with current legislation in the countries in which they operate. Although the services may differ in complexity, they include diagnosis, planning and management of communication with the internal public of the companies: their employees. The company confirmed that it prioritizes those companies that have accountability policies, with sustainability reports above all. Employee communication services can be provided to companies in different industries, Governmental agencies and Non Governmental Organisations. ABcom doesn't use a pricing scale to sort companies by industrial category. The current practice is to participate in price checks or tenders according to the client's contracting policy.
MANAGEMENT COMMENTS	All new clients are usually won prior to an extensive negotiation that involves the service scope description, pricing, timeschedule, and resources required to deliver the expected services. To participate in a tender or pricing bid, AB Com -as potential supplier- is requested to present credentials. In exchange, we also look into the potential client's corporate reputation (we check their sustainability reports, corporate and social media information).
