TOPIC	Company's facilities are located inside a National Park in North Western Argentina
SUMMARY OF ISSUE	<p>Volterra's main service involves tours in vehicles across the Talampaya Canyon. Volterra has invested in and operates a facility located in the Talampaya National Park. The facility consists of camping area, restaurants, parking area for vehicles, sanitary facilities, reception and tourist information center, mobile charging points and souvenir shops.</p> <p>The National Park's purpose is to protect an important geological, archaeological and palaeontological area. The National Park is a desert in North Western Argentina and consequently has no availability of resources such as raw materials, water, fuel, etc. These resources have to be carried over from 60 km away from the park.</p>
SIZE/SCOPE OF ISSUE	The majority of land under management is located in the sensitive ecosystem. The company also has an informational office in Villa Union (60km from the park) and an administrative office in Córdoba.
IMPACT ON STAKEHOLDERS	The facilities are located inside protected/sensitive ecosystems and thus can potentially impact the flora, fauna and quality of the ecosystem.
IMPLEMENTED MGT PRACTICES	<p>The facility is in an area designated by the Administration of the National Park for tourist use and tourist activities. The choice was based on an environmental impact assessment carried out by the National Parks Administration, before granting the license to Volterra SRL.</p> <p>The company has implemented an environmental management system, that is ISO 14001 certified. The certification is renewed at regular intervals. The company conducts a detailed impact analysis that covers aspects as such management of waste, energy, water, maintenance of pathways, employee and visitor awareness . Additionally, the National Parks Administration also monitors the activities that take place at the company's facilities.</p>
