



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>TOPIC</b>	Ongoing
<b>SUMMARY OF ISSUE</b>	Food huggers utilizes a freelance marketplace to connect with workers with specific skills that are needed in the company. The company usually hires workers through these platforms for positions that requires 5-10 hours a week.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	Approximately, 35% of workers involved in the operation of Food Huggers are hired through freelance marketplace online platforms.
<b>IMPACT ON STAKEHOLDERS</b>	Different hiring models can affect workers financial stability and forecast of workload. In addition to that, some forms of working agreements may result in fewer benefits for workers and make it difficult for them have their rights respected and have access to protections established by law.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>Food Huggers claims that their team of autonomous workers is free and outside of the control of the company. Food Huggers provides guidebooks, manuals, videos of instruction and other auxiliary materials, but workers are free to do their work whenever is suitable for their personal schedules and they have choice and influence on how they solve problems and approach their work.</p> <p>Food Huggers autonomous workers are free to work for other clients and adapt their schedules as it suits them better. The hours of availability and demand are pre-arranged between the company and workers, providing greater predictability to workers regarding payments and workload. In addition to having predictable billable hours and the flexibility to work those hours within their own schedules, Food Huggers offers several programs outlined in their Team Member Handbook aimed to give support and security to the individual members of their team.</p>
