Summary of Issue	Forecast Consulting provides financial performance consulting services, including tax-related services.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Tax consulting services are offered as part of the financial performance consulting services, which corresponds to 100% of the company's annual revenue. Forecast Consulting serves SMEs, non-for profits, and public organizations.
Impact on Stakeholders	B Lab recognizes fair payment of taxes as a material business issue and has a Framework for Evaluating Tax Strategies for B Corp Certification. Given Forecast Consulting limited scope of tax-related services in Belgium only, its services are consistent with the principles that (1) the amount of overall taxes paid over time appropriately reflects the actual amount of income generated by the client, and (2) the amount of taxes paid over time in each jurisdiction appropriately reflects the actual operations of the client in that jurisdiction.
Implemented Management Practices	Forecast Consulting tax consultancy services claims to respect all legal prescriptions. The company works closely with Belgian authorities in order to ensure that their customers' subsidy and tax exemption files are complete and legal. The company does not offer its services to low-tax jurisdictions. Forecast Consulting has never faced any penalties related to their tax services.  The company has in place a Conflict of interests Charter, a Whistleblowing policy, and a Code of Conduct applicable to all its employees and collaborators.
Reports	Forecast Consulting doesn't have the policies cited above publicly available yet. However, we suggest adding them to our future publicly available B-Corp profile.
