- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Animal Products and Services
TOPIC	Company is a manufacturer and sources >50% of their raw material expenses from animal products
SUMMARY OF ISSUE	The company operates a small bee farm and sources honey and other bee products from family bee farms in Oregon.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company sources from beekeepers that operate from 200 to 500 bee hives. The hives are kept throughout various farms and wild lands in the Pacific Northwest. The beekeepers move their hives to small farms in the region for pollination contracts that farms hire them to complete.
IMPACT ON STAKEHOLDERS	Animal agriculture poses a risk to local ecosystems of flora and fauna. The company relies on analysis of the purchased honey to ensure that it hasn't been contaminated with antibiotics, pesticides, or sugar, all of which would indicate poor beekeeping practices. The company also maintains regular contact with the beekeepers and discusses beekeeping practices with them.
IMPLEMENTED MGT PRACTICES	The company only sources honey from a local network of trusted beekeepers. They do not work with honey distributors, or import honey. This allows the company to have direct relationships with the beekeepers, visit their apiaries, and discuss beekeeping methods. The company has specifications for antibiotic residue and pesticide residue in honey, and they perform 3rd-party laboratory testing on their honey. These tests help to protect the customers, and also indicate good beekeeping practices. If an incoming lot of honey were to fail testing it would be rejected.
MANAGEMENT COMMENTS	The company believes that they are making the most sustainable choice by sourcing directly from local beekeepers, and that this choice also has the biggest positive impact on the local economy and agricultural communities
