Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	GreenA Consultants offer certification consultancy services to companies in Singapore and have clients in the Defense and Pharmaceuticals industries over the last 5 years. Services to these clients have involved the implementation of Green Mark feasibility studies for buildings; all services that can be offered to both clients in controversial as well as non-controversial industries. The company no longer works with clients in the Defense nor Pharmaceutical industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients operating in the Defense industry represented 1% of the company's FY2023 revenue. Clients operating in the Pharmaceuticals industry represented 0% of the company's FY2023 revenue; engagement with this industry was through an engagement in 2021 representing 4% of the company's revenue at the time.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	GreenA Consultants do not currently have a position on working with clients in controversial industries, however before working with clients that could be considered controversial, they ensure that the client understands that the green-buildings initiatives and practices would be audited and are transparent to mitigate potential risks of greenwashing. All of the company's consultants are certified Green Mark Accredited Professionals. The company does not carry out a due diligence process of their clients prior to working with them.

Management Comments	Our commitment to sustainability and ethical practices guides our work with all clients, including those from controversial industries. By providing green-building certification consultancy, we strive to help these industries reduce their carbon footprint and transition towards sustainable practices and collective environmental responsibility. Through these rigorous and evolving standards approaches, we aim to foster significant environmental improvements and encourage industry-wide shifts towards global sustainability targets.
