The nature of the company's services with clients in these industries has been related to assisting companies in achieving and meeting their sustainability standards and targets, all services can be sold to both controversial and non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients operating in the pharmaceutical industry represented 90% in FY22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact on stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have any positions in working with clients in sensitive industries.
	The company does not have due diligence in place as the service to ensure that the services provided by the company are not used for harming people and the environment as the company assists clients in achieving and meeting their sustainability standards and targets.
	The company does not require its clients to follow any code of conduct.
Management Comments	They have their Core Company Values as 'sustainability' and only work with companies and locations where they are sustainable and Ethical. They recently refused to support Astra



Zeneca in Russia as it would not comply with their Values.

Sustainability and HVAC Engineering Guides.

The Business supports reducing Carbon, Costs, and Consumption of finite Resources, as well as improving the safety of medicines produced in more Compliant Cleanrooms. They have helped to influence the Internation Standard ISO 14644 Part 16, which opened the way for better Energy efficiency in cleanrooms, as well as Majot's contribution to ISPE

They have supported GSK in influencing the WHO Cleanroom Standards and have supported discussions with the FDA, MHRA, And European Medical Inspectorate to engage in more sustainable practices support.
