Issue Date	June 1, 2020
Topic	Significant layoffs due to COVID
Summary of Issue	In 2020, during the initial COVID-19 lockdown period, Lintbells experienced 1 round of significant layoffs. Those impacted were predominantly in field based sales roles, with the inability to access customers at the time - and no foreseeable change. Lintbells utilized the furlough scheme and provided an enhanced redundancy package to support affected employees during this period. Midway through 2020, Lintbells experienced a boost in certain departments and initiated a recruitment project.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	17 employees were laid off, accounting for 26% of the company's workforce at that particular time.
Impact on Stakeholders	Primary impact was loss of employment for affected employees.
Implemented Management Practices	The company provided comprehensive support to all affected employees during the layoffs. This support included: 1. Severance Pay: Employees received severance pay, which ranged from 1 to 3 months, in addition to any statutory redundancy pay if applicable. 2. Legal Support: Legal support was offered to ensure that employees had access to necessary guidance and assistance during the process. 3. Standard Reference: A standard employment reference was provided to assist employees in their job search. 4. Continued Benefits: Some individuals had the option to continue their Private Health Insurance, and they were allowed to retain company equipment for a specified period to aid their job search. 5. Outplacement Coaching: Certain individuals received support through outreach coaching to help them navigate their career transition.

	Lintbells' policy is to always adhere to relevant legislative and legal requirements in any layoff situation in any country. Additionally, they assess the specific circumstances surrounding layoffs and provide additional support as needed, depending on affordability and the individual needs of impacted employees.
