



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The Duppy Share is a wholesaler that earns a material amount of reveue from the sale of beer (alcohol)
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% of Beer52's revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	Based on Edinburgh, the company is a wholesaler of beer/alcoholic beverages. The company complies with all UK alcohol-related laws and regulations. As the company sells on-line, the staffs of the company are not directly involved in the selling of alcohol. The company is labeled as a WOWGR ("Ware housekeepers and Owners of Warehoused Goods Regulations") holder, which is a requirement for the sale of alcoholic beverages in the UK. The company's website and their courier service providers perform age verification to deter minors from purchasing alcohol. In addition, the company's subscription model limits its attractiveness to minors as they are unable to get instant access to once-off alcohol purchases.
