Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Spring Lab SAS is a transformation & innovation consulting firm based in France. The company earns revenue from clients in the payday, short-term, or high-interest lending; for-profit higher education; pharmaceuticals, fossil fuels - coal, oil sands; and nuclear power or hazardous materials industries. The services provided are: change management advice, training and support; hackathons and workshops facilitation, and coaching training.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In 2022, the percentages of company's revenue generated from services provided to clients in these industries were: 1. Payday, short-term, or high-interest lending: 22.6% (40% in 2021) 2. For-profit higher education: 0% (0.12% in 2021) 3. Pharmaceuticals: 14% 4. Fossil fuels - coal, oil sands: 2.5% and 5. Nuclear power or hazardous materials: 5%
Impact on Stakeholders	B Lab's view is that companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, B Lab's view is that companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have any implemented practices applicable specifically to any of these industries, however, it has an ethics committee that can be convened if the company believes that a project can impact its mission. This committee has the accountability to approve or reject projects.
