



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	September 2019 and March 2020
TOPIC	2 non-connected rounds of layoffs
SUMMARY OF ISSUE	In 2019 and 2020, the company had 2 rounds of layoffs totalling to 13 employees. The layoffs were not connected. They were a result of A) the discontinuation of a co-working space and a new strategy (7 people) and B) COVID (6 people).
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	13 employees were laid off, representing 50% of the company's employees at that time, combined.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	All employees were offered free external coaching during workhours and company time off to take interviews. Several employees were offered the opportunity to keep their job with a new operator, and the company provided employees with references when applying to new jobs. All terminations were given with a minimum of 3 months (many longer) and were effectuated by guidance from the Danish Industry Association
OTHER MANAGEMENT COMMENTS	1 person decided to start his own small business as a builder/handyman and the company supported that by hiring him fixed 6 days per month. He now lives from his own company.
