## Disclosure Questionnaire Category: Other - Marketing of Breastmilk Substitutes

<b>Topic</b>	Company provided marketing services to breastmilk substitute clients
<b>Summary of Issue</b>	Sunhouse Creative is a brand design agency based in the UK that provides marketing services for Danone's Breast Milk Substitute (BMS). To manage risks and comply with the standards outlined in the BMS Call to Action, Sunhouse Creative has implemented additional policies to regulate its collaborations in this area.
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	In the last fiscal year, the revenues from BMS marketing services accounted for approximately 31% of total revenues.
<b>Impact on Stakeholder(s)</b>	The marketing practices of companies involved in the production and sale of breastmilk substitutes (defined by the WHO as products for infants aged 36 months and under), are controversial because of the risk that certain marketing practices may create an undue influence on a mother's choice to breastfeed, which could in turn negatively impact the health of infants.
<b>Resolution</b>	<p>In line with B Lab standards, Sunhouse Creative has established a Code of Ethics applicable to all employees and critical third parties. This code sets minimum expectations regarding anti-corruption and bribery, lobbying and advocacy activities, interactions with healthcare professionals and organizations, and ethical marketing, including matters related to BMS.</p> <p>The company has also established an accessible whistleblowing channel and provides regular training for staff and relevant third parties. Additionally, it promotes the prevention of aggressive marketing practices, particularly concerning BMS products, and has developed ethical marketing guidelines aligned with the BMS Call to Action.</p> <p>Sunhouse Creative prohibits misleading marketing, undue influence on healthcare professionals, and sales incentives tied</p>

	to sales volume, in order to minimizing the risk of adverse impacts on public health and stakeholders.
<b>Implemented Management Practices</b>	<p>Sunhouse Creative has an Employees' Code of Conduct Policy that applies to all employees, temporary staff, agents, and contractors. The Code sets out expectations regarding anti-bribery and corruption, diversity and equality, and confidential reporting concerns. All staff are required to adhere to the Code, sign the employee handbook as confirmation, and complete annual anti-fraud training. An ethics-focused risk assessment is carried out by the Operations Director to identify and monitor emerging risks. Breaches of the Code are addressed through a formal disciplinary procedure, which includes a defined whistleblowing process and the right to appeal. Sunhouse Creative does not engage in lobbying activities, and its anti-bribery policy prohibits political donations.</p> <p>For BMS marketing, Sunhouse Creative implements additional compliance controls. The Account Director, Design Director, and Production Director are required to complete specialized training and assessments to ensure that all marketing materials adhere to the WHO Code and relevant client guidelines, such as the Danone Green Book and the Danone Blue Book. These roles are responsible for the final review of materials and for providing training to other team members on relevant accounts. Additionally, the company's Bonus Policy is discretionary and is not linked to the sales of BMS products.</p>
