SUMMARY OF ISSUE	As an alcohol distillery, Destileria Patagonica SAS operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue was earned from the sale of alcohol in the last fiscal year.
IMPACT ON STAKEHOLDERS	As a water intensive industry, distilling poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	"40% of the company's product is sourced from purchased demineralized water. The company uses 200 ml of water per unit sold. The company takes care of its use, minimizing disposal and making the washing and sanitizing processes of the plant more efficient. It does not use tap/ mains water, other than for washing plant equipment, which is less than 5% of the water used. The company is itself not located in an area of water stress.
