



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Jungle21 is a research marketing agency with clients in alcohol industries. Their services include marketing, production, social media and PR.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Alcohol Industry represents 6.3% of their total revenue for FY21.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	"The company develops advertising for a client that sells alcohol. The advertising service is developed complying at all times and in a rigorous way with the legal limitations established by the local government. All communications, including digital communications are pre-validated by AUTOCONTROL (https://www.autocontrol.es/), an organism of self-regulation of the advertising industry in Spain. The communication is always done following principles of responsible consumption, to a public of 18+ years and in the adequate time schedules according to regulations. Jungle21 has a client screening policy in place in which the New Business Committee, led by the general director and other members of the company, authorize or not the projects to be worked in. The screening criteria includes not to work with brands in the Tobacco and Betting industries.
