Summary of Issue	Hilson Moran is an Environmental Engineering Design Consultancy that has had clients in the Offensive Firearms/Weapons and Pharmaceuticals industries. Work with the client in the Offensive Firearms/Weapons industry involved the provision of an interior design of buildings services (lighting, air, conditioning etc) for an existing office. Services to clients in the Pharmaceutical industry involved design of Mechanical, Electrical and Plumbing (MEP) Services and Sustainability consultancy for office accommodation. Hilson Moran's services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients from the Offensive Firearms/Weapons industry represented 0.16% of the company's FY2022 revenue. The company no longer works with this client or industry. Clients in the Pharmaceutical industry represented 0.16% of the company's FY2022 revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has committed to not work for clients in the Offensive Firearms/Weapons industry in the future. Potential new clients are reviewed on a case by case basis, reviewing the scope of each project opportunity and Hilson Moran chooses to work only with clients where they believe they can contribute to reducing energy use and carbon emissions of the real estate in the built environment; improving the health and wellbeing of building occupants; making a positive contribution to the wider community and without
