Topic	Clients in Controversial Industries
Summary of Issue	Reciclarg Recycling Technology S.A. manages waste from electrical and electronics that has had clients in the Fossil Fuel (Coal, Oil sands), Water utilities and Alcohol industries. The nature of the company's services with clients in these industries has been related to recycling and reusing electronics, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the Alcohol industry represented 1.02% in FY22-23. The revenue from clients in the Water utilities industry represented 1.25% in FY22-23. The revenue from clients in the Fossil Fuel (Coal, Oil sands) industry represented 1.02% in FY22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has no positions on working with clients in sensitive industries. The company does not have due diligence in place for evaluating new customers as the service provided involves recycling and reusing electronics; which they believe is a service that does not harm people or the environment. The company does not have any code of conduct policy but the values of transparency and responsibility that are part of recycling are expected to be followed by their clients.
Management Comments	Once the waste is received, the company prepares a tax receipt



	(X32) that details each and every one of the waste received, which is turned into an annual report to be presented to the control directorate (DPA).
