Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Recalls

Sammontana S.p.A. Società Benefit reported conducting 4 mandatory and 0 voluntary recalls in the past five years, representing 1.45 of the company's products for the same period. Sammontana S.p.A. Società Benefit reported that it had 2 accidents in the last 5 years. Accidental hazardous discharge poses significant risks to both the company responsible for the discharge and the surrounding communities. Accidental discharge can cause extensive damage to the environment, including contamination of soil, water bodies, and air. This pollution can harm ecosystems, wildlife, and vegetation, disrupt local habitats, and contaminate food and water sources.
