Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Operations located in Conflict Zones

Topic	Company has suppliers located in Conflict Zones
Summary of Issue	Koffiebranderij J.W. Hesselink & Zn BV is a coffee roastery located in the Netherlands that sources raw green coffee beans from Uganda and Ethiopia. The Global Conflict Tracker indicates that Ethiopia is experiencing conflict and political instability, while the Fragile States Index classifies Uganda as a region of instability that is categorized as "alert." The company extracts green coffee from these areas due to the flavours of the beans.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	15.5% of the company's purchases are sourced from areas that are located in conflict zones.
Impact on Stakeholder(s)	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	Koffiebranderij J.W. Hesselink & Zn BV only purchases certified Fairtrade and Rainforest coffee through cooperatives. Annually, the company contacts the coffee supplier to ensure they align with the company's values and to review the working conditions and transparency throughout their supply chain.
