



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Litigation related to Deceptive Advertising
SUMMARY OF ISSUE	There were two main cases of litigation found for Bigelow Tea. Both allege deceptive advertising practices related to claims made on packaging. The ongoing case is a Class Action suit related to alleged deceptive advertising and labelling practices.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the last 5 years, Bigelow had 2 deceptive advertising lawsuits filed against the company. The total amount claimed in said proceedings is approximately \$200,000 USD, and one case is currently pending resolution.
IMPACT ON STAKEHOLDERS	For both aforementioned cases, the plaintiffs alleged deceptive advertising and labelling practices.
IMPLEMENTED MGT PRACTICES	Bigelow has taken actions to address this issue. During a recent redesign of the consumer facing packaging, Bigelow made numerous changes to better increase the clarity of the messaging. In addition, Bigelow recently hired a regulatory specialist in the Food Safety and Quality Department to help monitor and advise packaging design including verbiage.
RESOLUTION	One of the cases was settled out of court while the other is currently pending resolution.
RELATED INCIDENTS (YES/NO)	A related incident has occurred. As is common in these situations, a "copycat" class action of the case currently working toward resolution in California has been recently filed in the state of New York.
