



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>DISCLOSURE QUESTIONNAIRE CATEGORY</b>	Animal products and services
<b>TOPIC</b>	Seafood industry
<b>SUMMARY OF ISSUE</b>	Vital Choice is a direct to consumer retailer of wild seafood and other food products.
<b>SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)</b>	~80% of the company's revenue in the previous fiscal year came from seafood, and 42% of seafood sales came from MSC certified fisheries.
<b>IMPACT ON STAKEHOLDER(S)</b>	There are several social and environmental risks associated with the global seafood industry, including poor labor conditions, human rights violations, impacts on biodiversity, and impacts on ocean health. Supply chain traceability in the seafood industry is challenging, which contributes to the continued prevalence of these issues globally.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>Vital Choice can trace all of its seafood products back to the fishery level, meaning they know where each fish was caught and which company processed it. For certain species, the company has traceability back to the fishing vessel, although this level of traceability is not yet available for a majority of products.</p> <p>Vital Choice requires that all US seafood is either certified MSC, or rated "Good" or "Best" by Seafood Watch. For non-US fisheries, the company requires the suppliers have Fair Trade certification or an equivalent assurance standard. If a fishery loses its certification status in some way, Vital Choice re-evaluates if it can continue to carry their product.</p> <p>These supplier screening criteria are monitored weekly by Vital Choice through interviews with its vendors. The company also undergoes MSC and Fair-Trade audits annually, for the products with end certification status (which includes vendor analysis).</p>
