TOPIC	Company tests their pet food for digestibility and palatability.
SUMMARY OF ISSUE	Earth Animal is a US-based company that produces and sells veterinarian-formulated dog foods, pet treats, pet remedies, and supplements for both dogs and cats. In partnership with veterinarian clinics, the company conducts non-invasive digestibility and palatability tests on animals. This process is not legally required by local or national regulation, the company undertakes this process in aid of production and marketing standpoint. Testing involves feedings dogs their products in regular quantities and measuring analysis through animal preference (on preference tests - palatability) and fecal outputs (for digestibility tests).
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Earth Animal runs palatability, digestibility and longevity tests for the products it produces. These represent about 90% of the company's annual revenue.
IMPACT ON STAKEHOLDERS	Animal testing and experimentation is widely used to develop new products and to test the safety of other products. Many of these experiments can cause pain to the animals involved or reduce their quality of life in other ways. The company does not partake in any invasive procedures with their animals, thus, minimizing the discomfort to the animals.
IMPLEMENTED MGT PRACTICES	Earth Animal has a public Animal Welfare Framework where the company states respecting the Five Freedoms of Animal Welfare, committing to making sure that animals have a good life and that a good life requires good nutrition, good environment, good health, good behavior, and good mental state, - The company conducts testing for its own products. The external products are not tested on animals, but rather tested in a simulated environment, without the animal present (ie – flea/tick collar), - The tests conducted by the company are the following: preference (determining which flavors dogs choose when presented with options), palatability (determining if the dog enjoys the flavor enough to keep chewing), digestibility, and longevity (how long it takes the dog to chew it). These all happen in a free-range environment with no forced behavior or laboratory involvement. - Earth Animal conducts in-home tests with pet parents (which represents 75% of the company's tests) as well as testing on a facility located at a farm (which represents 25% of the testing), - The company has a partnership with this facility located on a farm. This facility has a formal Animal Welfare Statement where it states conducting only non-invasive tests on the animals (cats and dogs). At this farm, the animals receive routine veterinarian care where the professionals monitor the animals' health, - The company conducts in-house testing with consumers who own pets. For preference tests, that determine pet preference between samples, pet owners presented the samples to their animals and registered the results that were analyzed by a specialized company. Digestibility tests are conducted in-home with a panel of owners and their pet dogs. The dog feed is tested for acceptability, feed efficiency, mass balance, and stool quality. Owners are trained to feed their pets exclusively the test dog food, excluding all other foods, treats and table scraps from their diets during the full-test period. Owners also have to observe their pets' behavior. Pet

OTHER MGT COMMENTS	As a health and wellness company, Earth Animal stated being committed to guaranteeing that all animals impacted by the business have a good life. This is shown on the company's Animal Welfare Framework. To that end, the only tests conducted by the company are non-invasive. It does not conduct laboratory experiments with any animals.
