



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	March 2019
TOPIC	Significant layoffs to safeguard the economic viability of the company.
SUMMARY OF ISSUE	In a period of strong growth, Just Spices needed to decide whether to invest massively into their own production facilities or to rely exclusively on suppliers they were already working with, with strong quality assurance certifications. To safeguard the economic stability of the company, ensure a safer cost structure as well as keeping a high quality level of the product, the decision was taken to fully outsource the production which resulted in the lay-offs.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	27 employees were laid off in March 2019, representing 24% of the company's employees at that time. Just Spices managed to keep 4 employees which were transferred in other departments
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company has provided employees with the following support: - provided them with networking opportunities to find a new job - offered employees open office hours to discuss with the HR department, a job application trainer to go through and optimize applications with them and asked other companies directly if there were any jobs available.
