Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Industries at Risk of Human Rights Violations and Suppliers in Conflict Zones Forced labor, child labor, and human trafficking risks in coffee industry. Cooperatives Coffee has part of their supply chain based in conflict affected areas of Democratic Republic of Congo and Mexico. As a purchaser of coffee, the company operates in an industry in which human rights issues such as forced labor, child labor, and human trafficking may exist.
Cooperatives Coffee has part of their supply chain based in conflict affected areas of Democratic Republic of Congo and Mexico. As a purchaser of coffee, the company operates in an industry in which human rights issues such
Cooperatives Coffee is a coffee importing cooperative that supplies part of their coffee from Democratic Republic of Congo (DRC) and Mexico.
The company works with the SOPACDI and Muungano cooperatives, which are respectively headquartered in Minova and Kinyezire in the province of South Kivu in East DRC. The Democratic Republic of Congo is in the List of Fragile and Conflict-affected Situations of the World Bank of 2022. The country is also classified as a politically unstable by the Council on Foreign Relations and is ranked 6th in the 2022 Fragile States Index.
In Mexico, the company works with the Maya Vinic and Yachil Xojobal Chul'chan cooperatives, located in Chiapas. The Inter-American Commission on Human Rights has identified the existence of territorial conflicts between different communities that have resulted in deaths and injuries, as well as several events of forced displacement of communities in the area of Chiapas.
The purchase of coffee is approximately 100% of Cooperative Coffees overall supplier expenditure. 4.7% of the company's expenses were with suppliers located in conflict affected areas in 2021.
High risk supply chains such as cocoa, coffee, tea and palm oil have a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking. As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law.
Cooperative Coffees claim that all the organizations they choose to partner with are democratically run cooperatives and producer associations. In these kinds of organizations, management is accountable to the cooperatives'/associations' board of directors, and ultimately to a general assembly. Through the cooperative's governance system there is a certain level of transparency and accountability that is guaranteed. Furthermore, these organizations are social enterprises with zero tolerance policies towards violence. In addition to that, 100% of all their coffee and 100% of the products sourced from DRC and
Mexico are Fair Trade Certified.
