SUMMARY OF ISSUE	Team Unico operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.

IMPACT ON STAKEHOLDERS	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	The company does not control any land. We only work with farm suppliers that meet additional screening requirements for farm suppliers - pesticide and herbicide program, inter-row planting program, soil management program, environmental protection plan. Physical farm visits at a minimum of every 3 years.

SUMMARY OF ISSUE	As a vineyard and winery, Team Unico operates in an industry that is water intensive. Aspects of the industry that make it water intensive include irrigation used in the cultivation of vines, water used in the winemaking process (e.g. for cleaning tanks and barrels), and water used in the bottling process.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	70% of supplier farms are irrigated with drip irrigation.FY20/21 litres of water used per litre of produced was 2.48
IMPACT ON STAKEHOLDERS	As water intensive industries, agriculture and wine production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	"Team Unicoo uses varieties specifically adapted to low water use and work with growers who have implemented water management practies such as, soil moisture monitoring, interrow cropping, mulching and drought resistant rootstocks. This is recorded in our supplier records. Team Unico utilises water ratios for production are monitored and benchmarked against the wine industry.  Team Unico undertakes screening of farm suppliers for best practice such as wastewater collected and recycled etc."
