Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Litigations Related to Labor
Summary of Issue	Harts Alimentos Naturais LTDA manufactures and sells natural and health-focused food products such as granolas, cereals, protein bars, snacks, and plant-based nutrition products. The company has been involved in labor litigations result of two former employees' claims alleging work-related health conditions and seeking compensation. One case was resolved through a judicial settlement and is now closed, while the other remains pending and is being addressed through ongoing legal proceedings supported by technical documentation.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The financial exposure associated with both litigations represents less than 1% of the company's total revenues.
Impact on Stakeholders	Potential impact on the former employees' health conditions.
Resolution	One matter was resolved through a judicial settlement and has been closed. The second matter remains pending and is being addressed through ongoing legal proceedings.
Management Practices	The company addressed these matters through legal review processes, expert evaluations, supporting documentation, and, where appropriate, judicial settlement. To help prevent similar issues in the future, it strengthened occupational health and safety programs, enhanced training on the proper use of personal protective equipment (PPE), and reinforced workplace risk management and monitoring practices.
