



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Sale of dogs and cats in store
SUMMARY OF ISSUE	"Truffaut is a company in France that primarily sells plants and gardening supplies. A small portion of their revenue (~3%) was comprised of selling pets, including dogs and cats. Other pets include fish, rodents, and reptiles. France recently passed animal welfare legislation that prohibits the sale of dogs and cats in pet stores by 2024. As of February 2022, Truffaut has ended all their contracts with suppliers of dogs and cats. "
SIZE/SCOPE OF ISSUE (e.g. \$ financial implaction, # of individuals affected)	In 2019, pet sales represented ~3% of revenue.
IMPACT ON STAKEHOLDERS	The sale of pets in stores raises potential animal welfare concerns related to the company's treatment of the animals and their suppliers' treatment of the animals. Common risks include failure to provide proper veterinary care and unsanitary living conditions.
IMPLEMENTED MGT PRACTICES	"As of February 2022, Truffaut has ended all their contracts with suppliers of dogs and cats. For all other pet sales, Truffaut has the following management practices in place: - ISO 9001 certified (specifies requirements for a quality management system) for animal welfare - Code of Conduct for suppliers - Employee training on animal welfare - Store processes that include, specific to each animal, food and water, regular vet appointments, exercise routines - Customer interviews where employees evaluate the customer's ability to care for the pet"
