### **Disclosure Materials**

| Summary of Issue   | Danone Canada is an indirect subsidiary of Danone S.A., and it has achieved independent B Corp certification.   |
|  | In the last five years, Danone Canada has had three (3) consumer protection litigation cases related to the national recall of the products Silk and Great Value-branded plant-based products.  |
|  | <ul> <li>There are currently two (2) class action lawsuits and one (1) small claims case related to the recall of Silk and/or Great-Value branded products.</li> <li>Both class action lawsuits- one in Quebec and one in British Columbia - allege that the recalled products were contaminated due to issues involving the third-party manufacturer and packager of the product, Danone, and a third-party retailer. The plaintiffs are requesting national class action status and are seeking financial compensation for either product-related losses or personal injury.</li> <li>The small claims court case alleges personal injury was caused by the recalled products.</li> </ul> |
| Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected) | The total financial value compensation sought by the three (3) cases together represents less than 1% of the company's revenues.  |
| Impact on Stakeholders   | These litigation cases refer to the consumer protection topic, more specifically, a recall due to a contamination of Listeria monocytogenes in certain beverage products produced by a third-party manufacturer.  |
|  | Therefore, the main stakeholders affected are the company's consumers who suffered physical and financial harm.   |
| Resolution   | The class action lawsuit in Quebec has a settlement in principle for the certification of a national class, reached, with a   |



settlement approval motion scheduled for December 12, 2025. The class action lawsuit in British Columbia is currently progressing through a timetable for certification. For the small claims case, the case is currently inactive. **Implemented** Since these litigation cases refer to the recall of Silk and/or **Management Practices** Great-Value branded products, the implemented management practices are the same as the ones implemented at the time of the recall. Danone Canada implements a thorough food safety policy & procedures, in accordance with Danone global policies and guidelines. The company complies with the Safe Food for Canadians Act in Canada and, as such, has implemented preventative controls and a Preventive Control Plan to bring the risks associated with chemical, physical, and biological hazards to an acceptable level. |  | In the last five years, Danone Canada has had two (2) product recalls across Canada.  |
|  | Recall 1 (Silk refrigerated plant-based beverage) In July 2024, the Canadian Food Inspection Agency (CFIA) confirmed several cases of potential contamination of Listeria monocytogenes linked to select Silk refrigerated beverages produced on a specific production line in a third-party manufacturer in Ontario and distributed by Danone Canada.  |
|  | Danone Canada, together with the CFIA, issued a voluntary recall on 15 Silk refrigerated plant-based beverage SKUs. Danone Canada also preventatively halted all production and shipments coming from this facility to carry out a thorough investigation. The CFIA and Public Health Canada (PHAC) closed their investigation in October 2024, stating that they considered the outbreak to be over.   |
|  | Recall 2 (Kirkland Signature Probiotics Yogurts) In September 2024, Danone Canada recalled Kirkland Signature Probiotic Yogurts sold in a 24-pack format at Costco between September 3, 2024, and September 19, 2024, as there was a possibility the product may contain a type of yeast that could cause illness to individuals with a compromised immune system. The food safety risk was low, as the yeast in question is not known to grow in refrigerated temperatures. The Canadian Food Inspection Agency (CFIA) also classified the recall as a Class ,3 which indicates there is a low risk that consuming the food may result in any undesirable health problems. |
| Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected) | Recall 1 required the interruption of all plant-based products derived from this third-party manufacturer.  |

| Impact on Stakeholders           | <ul> <li>The most significant impact in the context of a food recall is always on the potential harmful effect on consumers' health and safety.</li> <li>For recall 1, the CFIA identified 20 laboratory-confirmed cases of Listeria monocytogenes illness linked to this outbreak, including 15 hospitalizations and 3 deaths.</li> <li>For recall 2, 70 consumers reported illness through the company's channel.</li> </ul>   |
| Resolution                       | Recall 1 As soon as Danone Canada became aware of the issue, it acted immediately to voluntarily issue a recall for the affected SKUs across Canada, preventively halted production and shipments from the affected facility, and collaborated with health authorities to facilitate transparency, communication, and implementation of all corrective actions to resolve the issue.  Recall 2 As soon as Danone Canada became aware of the issue, it  |
|                                  | issued a voluntary recall directly through Costco for the affected SKU across Canada. Given the Costco membership model, sales records were able to be leveraged to issue notices directly to those consumers who had purchased the affected product between September 3, 2024, and September 19, 2024.  |
