Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Animal Testing

Topic	Company tests its dog toys and treats to evaluate their design, functionality and durability.
Summary of Issue	West Paw, Inc. is a pet products company based in Montana in the United States. All of the company's products are designed for play, puzzles, or chewing with a dog, or in the case of treats, providing rewards for good behavior. The company tests its products with animals to see how they interact and use them. This kind of testing is not legally required by any local or national regulation. The company undertakes this process to evaluate their products' design, functionality and durability. The materials the company uses in its products are non-toxic and human food safe grade.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The company releases approximately 5-8 new products per calendar year and all products are tested. These make up 100% of annual revenue.
Impact on Stakeholders	Animal testing and experimentation is widely used to develop new products and to test their safety. Many of these experiments can cause pain or discomfort to the animals involved, or reduce their quality of life in other ways.
Implemented Management Practices	West Paw, Inc. undertakes the testing process internally and all of the company's testers, called the West Paw Chew Squad which is a mixture of employees and non-employees, are known to the organization. Before they can officially become a member of the Chew Squad, prospective testers must fill out a questionnaire that allows the company to review and screen prospective testers. The company shares a Chew Squad Training Manual with all Chew Squad members, outlining guidelines on how the owner should utilize the toy with their dog to both test the product and ensure the dog is not at risk. The company does not have a specific animal welfare policy nor a public-facing position regarding animal testing.
