

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

SUMMARY OF ISSUE	Labor suits involve actions filled by former employees relating, among other things, severance pay, statutory pension insurance and termination of contract.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company had 2 closed labor litigation (settled). The financial value of these lawsuits was € 278,000. Currently, there are 2 pending labor litigation regarding similar matters and the total projected payout of these lawsuits is € 81,000.
IMPACT ON STAKEHOLDERS	The primary impact related to labor litigation is a financial impact on former employees.
IMPLEMENTED MGT PRACTICES	By the following practices, the company strives to avoid receiving similar claims: - Developing employee-friendly employment contracts and company agreements with employees. - Working with workers' councils that represent the needs of the employees. - Conducting ongoing discussions such as development conversations and people surveys, - Implementing an early warning system during the employment relationship, which is intended to identify discrepancies early on and to solve them, - The company stated that legal disputes are only the last resource, tending to conduct agreements.
