OTHER MANAGEMENT COMMENTS	The company trusts the Supplier is managing hives as per their commitment to limit overstocking and maintain the maximum number of hives in a set area of 1 per hectare (for Manuka) to ensure plentiful food sources. NZ Native Honey is implementing a Supplier Code of Conduct that it intends to use for Supplier screening on animal welfare and setting. Pls on animal welfare. Currently, the company places trust in the Supplier to ""Do the Right Thing"" and gives credit to the Supplier for achieving the BCorp Certification. NZ Native Honey hasn't set any. Pls but plans to implement in 2023. The company has no third-party certification."
