



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As a company that offers irrigation system solutions, Riego Chile operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company derived 100% of its revenue from the irrigation system solutions segment in 2021. The company per se is not water intensive, however, their solutions are designed to address water usage in water intensive industries.
IMPACT ON STAKEHOLDERS	Water intensive industries pose risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	Riego Chile designs solutions and systems to avoid water waste and increase the efficacy in water usage in water intensive industries. For each irrigation project, the company conducts an agronomic study to quantify and determine what is the precise volume of water necessary for the clients' specific needs. Flow meters are also installed in the irrigation systems, which control the use of water and an automatic irrigation programmer that controls the irrigation time.
MANAGEMENT COMMENTS	Riego Chile designs automation and control systems for hydraulic and/or irrigation systems. The company would like to highlight that they reduce energy consumption through a conceptual design for the irrigation system. They promote the construction and use of renewable energy plants for irrigation systems.
