



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Clients in controversial industries
TOPIC	Clients in the Alcohol industry.
SUMMARY OF ISSUE	Trampoline Design is a design and Marketing agency that provides label design for the packaging and cans of beer for some breweries. The company's service does not contribute to the management of harm attributed to the alcohol industry, Trampoline Design provides the art work that goes on to the product; any ingredient list or warning label is provided by the client, in compliance with local and federal law. The company's service can be sold to clients in both controversial and non-controversial industries, with the same fee structure.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 0.22% of the company's revenue was derived from clients in controversial industries, corresponding to different clients operating in the alcohol industry (both breweries)
IMPACT ON STAKEHOLDERS	Companies serving clients in controversial industries have the potential to further the negative social and / or environmental impacts of the controversial industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	The company selects client partnerships based on their core values. When it comes to working with breweries, the company prioritizes shared values over the beer industry itself. Their decision to collaborate with specific brewers is driven by the brewers' commitment to their local community, demonstrated through their use of local ingredients, responsible material sourcing, and the employment of local staff. The company values these community-driven principles more than simply being associated with the beer business. Conversely, the company consciously avoids partnerships with sensitive industries. The company's policy explicitly states their preference for working with clients and suppliers who share similar values, with a focus on benefiting the community and the environment by supporting local, independently owned organizations. They do not anticipate forming any future alliances that would compromise their values, nor do they have any desire to engage with sensitive industries that may pose harm to people or the environment.
