SUMMARY OF ISSUE	"Namidabashi Lab. offers consultation services for creating a space for dialogue in health development and health system strengthening in emerging economies. They provide services such as design, management and evaluation for technical cooperation or financial aid projects funded by the Japanese Government.
	Specifically, in 2019 the company executed an ex-post evaluation in Afghanistan for two projects of the Japanese International Cooperation Agency (JICA) focussed on community infrastructure and development in Nangarhar, Afghanistan. The objective of an ex-post evaluation is to ensure the objectivity and transparency of the evaluation results.
	For this project, the company hired a local evaluation assistant stationed in Nangarhar province to support data collection activities and coordination between the implementing agencies of the project, the Independent Dependent Directorate of Local Governance (in Kabul and Nangarhar) and the company."
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company derived 22% of their revenue in 2019 from a project pertaining to the conflict affected area of Afghanistan. The funding for this project came from JICA and not from the conflict affected area.
IMPACT ON STAKEHOLDERS	"As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law.
	The security of company workers who work in such areas could also be at risk."
IMPLEMENTED MGT PRACTICES	"The company follows the following principles and practices when planning and carrying out peacebuilding works, which are contained in the company's ""Brief rules for works for peacebuilding in a conflict setting"":  1. Respects for human rights based on principles of internationally established human rights standards, with special attention to the human rights of underrepresented social groups in the conflict areas, including women, children, older adults, people in poverty, indigenous peoples,persons with disabilities, and others.  2. Identification and analysis of destabilising and stabilising factors along with an assessment of possible positive impacts and negative impacts of their projects. In some cases, the company refers to the Peacebuilding Needs Assessment (PNA) report published by the Japan International Cooperation Agency (JICA) that summarises the destabilising and stabilising factors at different levels (national, provincial, community, etc.) of the country of operation.  3. Analysis of the main stakeholders of the project i.e. members of their work, intervention or project, beneficiaries and other stakeholders who may have an impact on the project implementation. Prior to hiring local service providers or contacting local individuals or organizations, the company evaluates their characteristics and relationship with other stakeholders. In selecting a contractor, the company pays attention to their research capacity and the relationship with the target community.  4. Standing at a neutral position in a conflict and not reinforcing the conflict or destabilising factors. On the other hand, the emphasis in on reinforcing peaceful situations and stabilising factors. While sometimes it is unavoidable to be involved unintentionally in a conflict, the company takes care about what they say and do and review how others perceive their characteristics and relationship with stakeholders.
