### **Disclosure Questionnaire Category: Suppliers in Conflict Zones**

Торіс	Company has suppliers located in Ukraine
Summary of Issue	The Abbi Agency, based in Nevada (USA), provides full-service marketing and communications services. The company has five Tier 1 suppliers located in the Ukraine, which is currently an active war zone. The suppliers provide UX/UI design and development services.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the FY 2023 2% of expenses came from this supplier.
Impact on Stakeholders	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability.
	Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	As part of the suppliers' ongoing assurance practices in order to ensure that the company's purchases are not tied to the conflicts in those regions, The Abbi Agency has the ability to vet and audit its suppliers. The company conducts periodic audits/reviews to ensure continued adherence to ethical practices, including regular checks of their operational procedures, environmental and social impact, and any new certifications or compliance updates.
Management Comments	At The Abbi Agency, we take a thorough and ongoing approach to supplier vetting and hiring to ensure that our partnerships and employees align with our company values. Our process begins with an in-depth interview during which we assess their operational practices, ethical standards, and alignment with our commitment to social impact. We also review their qualifications, including resumes and any relevant documentation of their work history and compliance with industry standards. For hiring, we also will check references prior to bring them onboard. We have long-standing relationships with many of our Ukraine team, having worked with them well before the current conflicts began.

This history allows us to maintain a high level of trust while ensuring that all our team continues to meet our standards through continuous engagement and monitoring.
