



DISCLOSURE MATERIALS

SUMMARY OF ISSUE	As a demolition and construction company, Demoliciones Mitre operates in an energy intensive equipment in the form of heavy machinery, onsite generators and vehicles for transportation of workers and material.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	<p>The company has created an inventory of their carbon emissions focussing primarily on scope 1 and 2 emissions and some parts of scope 3. 97% of the company's carbon footprint is due to their scope 1 emissions of which 98% is related to their diesel consumption for their heavy equipment, vehicles and onsite generators primarily used at their construction sites.</p> <p>Based on their carbon inventory, the company has estimated their carbon emissions as 161.8 tonnes CO₂e / million USD of revenue.</p>
IMPACT ON STAKEHOLDER(S)	The carbon emissions associated with their operations and their contribution to climate change along with air pollution and associated health impacts of air quality are the potential impacts of their energy intensity.
IMPLEMENTED MGT PRACTICES	<p>The company has created an inventory of their carbon emissions for their offices, workshop and construction sites. The company has a target to be carbon neutral by 2030 and to reduce its carbon emission by 10% in 2020 when compared to a baseline of 2019.</p> <p>They have also identified a range of measures to meet the carbon neutrality target including carbon offsets through vegetation. Some of these measures have already been implemented such as switching to electric hammers, an electric demolition robot, etc.. The company has also conducted its first pilot test of replacing onsite power source for construction works, with solar panels.</p>
