



## DISCLOSURE MATERIALS

The company was started to help native wildlife in New Zealand flourish. In New Zealand, mice and rats are introduced species that negatively affect native species. The company has developed traps that use toxin-free lures, and the traps have been tested and meet humane standards as established by <a href="#">New Zealand's National Animal Welfare Advisory Committee</a> (NAWAC).</p> <p>In New Zealand, the traps are legally required to be tested on animals if used on the Department of Conservation. Furthermore, the NAWAC Guideline 09 "Assessing the welfare performance of restraining and kill traps" requires animal testing in order to prove the trap is in accordance with the guideline. The traps are also sold in the United Kingdom, where the traps are legally required to be tested on animals. The animal testing is in accordance with the laws and regulations of the relevant organization in each country, i.e., the National Animal Welfare Advisory Committee in New Zealand, and the Spring Trap Approval Order in the UK.</p> |
