Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	:Brio is a management consultancy that has had clients operating in the Alcohol, Pharmaceuticals, Nuclear Power or Hazardous Materials, Fossil Fuel (other than coal, oil sands) industries and a one-off engagement with a client operating in the Gambling Industry over the last 5 years. Services to clients in this industry have included multi-disciplinary expertise in strategy and alignment, change management and organizational design, leadership and performance, transformation design and implementation and organizational effectiveness. :Brio's services are tailored to the client's industry and needs and can be sold to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	:Brio has had a total of 10% of revenue from clients in controversial industries over the past 5 years. In the FY2022: • 1.25% of the company's revenue was from clients operating in the Pharmaceuticals industry, • 0.06% of revenue from clients operating in the Nuclear Power or Hazardous Materials industry • 5.92% of revenue was from clients operating in the Fossil Fuel industry • 0.64% of revenue was from clients operating in the Gambling industry. • 0% from clients in the Alcohol Industry (with 7,97% of revenue over the last 5 years).
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented	The company claims to not engage with clients who could

Management Practices	tarnish their image through practices that are incompatible with their values, and do not respect human rights or environmental rights. :Brio criteria for evaluating new clients or projects include whether they have a positive impact on the ecosystem and whether they are stimulating for their employees. The company has a position to oppose working in the defense and pornography industries as well as with companies selling illegal products.
