



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory Council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	March and September 2020
TOPIC	Significant layoffs due to pandemic brought by COVID-19
SUMMARY OF ISSUE	Withlocals is a free-to-join platform that connects local people with global travelers. The pandemic brought by COVID-19 has had a massive impact on company's revenue. As a result, company had to do 2 rounds of layoffs.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	On September 2020, 11 employees were laid off, representing 22% of the company's employees at that time. This round of layoffs came in close succession to layoffs conducted in March 2020 that affected 19% of employees at the time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	All affected employees received a severance pay package which is more than what was required by Dutch legislation. They were also provided with company laptops which are free of charge so they would be able to apply for other jobs. The company also proactively activated their network in search for new relevant opportunities, as well as offered them training and coaching to help them in their quest for new jobs. With these, 80% of affected employees were able to find new jobs within 6 months, and eventually, within a year, 100% of affected employees found their new jobs.
RELATED INCIDENTS (YES/NO)	The company had to do 2 rounds of layoffs: March and September 2020. On March 2020, 14 employees were laid off, representing 19% of the company's employees at that time.
