

DISCLOSURE MATERIALS

- 2) Describe how the company has addressed this issue.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	CMP&P is a point-of-sale/point of purchase (POP) display manufacturer. Company manufactures displays for both smoking cessation products and cigarette products.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 2.5% of the company's revenue was earned from Tobacco clients.
IMPACT ON STAKEHOLDERS	"Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. The negative impact of the tobacco industry, in general, is of great concern and importance due to its impacts in local communities wellbeing and health implications. This includes nicotine products and other products also known as ""reduced-risk products"" (e.g. IQOS). B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter."
IMPLEMENTED MGT PRACTICES	"CMP&P claims that their due diligence policy ensures their services are not inappropriately used to cause any harm or to promote illegal products. In particular, the personalization and customization of display allows them to be sure of what products are going to be promoted. All their displays are customized, regardless of the industrial sector. The customization of all the displays is tied to their due diligence process and related controls to understand where the displays are going to be disposed. This process allows CMP&P to be able to decide, in a conscious way, what types of services and products are not going to be offered, depending on the controversy of a potential client. Currently, what guides CMP&P to make a decisions is their charter of values, available to all their stakeholders."
