Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Animal Testing

Topic	Some of the company's products are required to undergo mandatory animal testing by law and some are optional
Summary of Issue	Bloomix develops microbial solutions for farmers to replace agrochemicals and synthetic fertilizers. Microbial biopesticides are required to be tested on animals by law to ensure safety. As for the microbial biostimulants there is no legal requirement for animal studies. Before proceeding with the animal testing, Bloomix internally evaluates the health related risks to decide when it is ethical to do animal studies.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the company's products undergo animal testing.
Impact on Stakeholders	Animal testing and experimentation is widely used to develop new agricultural products and to test the safety of other products. Many of these experiments can cause pain to the animals involved or reduce their quality of life in other ways.
Implemented Management Practices	Bloomix has an Animal Testing & Animal Welfare Policy and considers the use of animals to be ethically appropriate only when no alternative methods are available, the risks to impact human health are high, or when the use is mandated by legal or regulatory requirements. Bloomix outsources all of its animal tests to the University of Southern Denmark (SDU) with trained staff and proper facilities. The University follows Denmark's official rules for animal experiments and guidance from its own Animal Welfare Committee. All the company's animal tests have received prior ethical approval from Denmark's Animal Experiments Inspectorate. Bloomix fully adheres to the 3Rs: Replacement, Reduction and Refinement of animal use in its animal testing research. Based on those principles, the company only opts for animal use when a non-animal method is unsuited for the required use (replacement), the number of animals used is kept to a minimum (reduction), and practices are implemented to promote animal welfare and prevent animal pain and distress in housing and procedure conditions as much as possible (refinement).
