Issue Date	2022
Topic	Litigation related to dismissal with cause
Summary of Issue	In the past five years, Bingham Riverhouse was engaged in a single legal dispute initiated by a former manager who was dismissed due to gross misconduct. The issue was resolved through an out-of-court settlement.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total settlement value for this case represented about 2% of the company's total revenue. There were no other litigations against the company in the past five years and no other employee disputes.
Impact on Stakeholders	Both the company and the former manager were affected by this process.
Resolution	The case was resolved by the company paying a financial settlement to the plaintiff.
Implemented Management Practices	The company has implemented the following management improvements to mitigate such cases in the future: - Updating the Employee Handbook to include a Whistleblowing Policy to accommodate anonymous reporting. - Appointing Nassar Khalil as a non-executive director (NED) to ensure senior staff accountability and prevent theft and abuse of employee benefits.
