

## **DISCLOSURE MATERIALS**

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Environmentally Intensive Industries
As a manufacturer of personal care water-based products, Goodkind Co operates in an industry that is water intensive.
"Approximately 25% of Goodkind Co's annual revenue comes from water-based products.  These water based product can contain up to 70% of water by volume."
"As a water-intensive industry, the production of water-based personal care may cause water stress or depletion of local water sources if water use is not appropriately managed.  To manufacture these water-based products Goodkind Co utilizes a reverse-osmosis system which generates a material amount of water waste.
The company is not located in a water-stressed region. "
"- Goodkind Co stated that the majority of its products are anhydrous, which according to them have less of an impact than many in the industry who derive the majority of their revenue from water-based products,  - The company is currently in the process of upgrading its reverse-osmosis system which should reduce the amount of waste generated during the purification process (but not eliminate it)."
